GolfNow's Free Golf for Life Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: GolfNow's Free Golf for Life (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) and Canada (excluding Quebec) who are at least eighteen (18) years old at the time of entry. Employees of GolfNow, LLC, HelloWorld, Inc., and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state, provincial, territorial, municipal, and local laws and regulations and is void in Quebec and where prohibited. - **3. Timing:** The Promotion begins on January 27, 2015 at 12:00 a.m. United States Eastern Time ("ET") and ends on April 13, 2015 at 11:59 p.m. ET (the "Promotion Period"). Administrator's computer is the official time keeping device for this Promotion.
- **4. How to Enter:** During the Promotion Period, visit http://GolfNow.com/GolfForLife or http://GolfNow.com/WinGolf (each a "Website") and complete and submit the registration form including a valid email address. You automatically will receive one (1) entry into the Sweepstakes and advance to the Instant Win Game page and receive one (1) Instant Win Game play for that day. Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

Limit: Each entrant may enter/play one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. There will be fifty (50) second instant prizes ("Second Instant Prizes", each a "Second Instant Prize") Each Second Instant Prize will consist of the following: A GolfNow buy one round of golf, get one free promo code. Promo code must be used on any one (1) "Hot Deals" tee time reservation containing up to four (4) rounds booked on GolfNow.com. Offer will discount two players at 50%. Maximum value is \$40.00. Promo Code expires June 30, 2015.

There will be one hundred and twenty five (125) third instant prizes ("Third Instant Prizes", each a "Third Instant Prize"). Each Third Instant Prize will consist of the following: A GolfNow 25% off one (1) round of golf promo code. Promo code must be used on any one (1) "Hot Deals" tee time reservation containing up to four (4) rounds booked on GolfNow.com. Maximum value is \$40.00. Promo code expires June 30, 2015.

First Instant Prizes, Second Instant Prizes and Third Instant Prizes will be referred to herein as "Instant Win Prize" or "Instant Win Prizes".

Instant Win Prizes and Grand Prizes will collectively be referred to as "Prize" or "Prizes".

Odds of winning an Instant Win Prize depend on the number of Instant Win Prizes available divided by the number of eligible Instant Win Game plays. Limit: One (1) Instant Win Prize per person.

<u>For All Prizes</u>: No cash equivalent and all prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion.
